IN 2019, AUDREY'S ANGELS PROVIDED A TOTAL OF 6,855 HOURS OF INTERACTIVE MUSIC AND ART PROGRAMMING (AN INCREASE OF 6% OVER 2018), OF WHICH 796 HOURS (12%) WERE PROVIDED COMPLETELY FREE OF CHARGE. BY DECEMBER 2019, AUDREY'S ANGELS WAS SENDING 56 PERFORMERS AND ARTISTS EACH MONTH TO 184 ELDERLY CARE FACILITIES THROUGHOUT THE GREATER PHOENIX, ARIZONA AREA. INTERACTION WITH OUR ANGELS HELPS TO ALLEVIATE THE LONELINESS AND ISOLATION FELT BY MOST OF THE ELDERLY WE SERVE. MUSIC SESSIONS OFFER A FORM OF SENSORY STIMULATION WHICH PROVIDES POSITIVE RESPONSES DUE TO THE FAMILIARITY, PREDICTABILITY, AND FEELINGS OF SECURITY ASSOCIATED WITH THE MUSIC. CARE HOME OWNERS REPORT THAT 85% OF THEIR RESIDENTS DO NOT RECEIVE REGULAR WEEKLY VISITORS, SO FOR THAT LARGE POPULATION, AUDREY'S ANGELS COULD BE THEIR ONLY CONNECTION TO THE OUTSIDE WORLD.
